**Course Description:**

This course is a one credit course that may not be repeated. It meets on Thursday periods 11 – E1 (6:15PM – 8:10PM) in Gerson 126. There are no prerequisites. It is designed to instill in students an appreciation of the career opportunities in the practice of public accounting, industry, financial services, government, and in business more generally. Students also will be exposed to technical topics and emerging issues in accounting, business, and in related professions such as the law. The course will be delivered by guest speakers talking to the class about topics of professional interest. Most of these talks will provide a practicing professional's insights regarding technical issues and concerns affecting the accounting profession. . Some talks will relate to professional career planning as the speakers will discuss various specialty areas, unusual occupations, unique firm practice structures, or non-traditional career opportunities.

**Course Objectives:**

Upon completion of this course, students will:

- Be familiar with the ideas of professionals who are leaders in their fields
- Be able to discuss emerging issues in accounting, business, and related professions
- Recognize the diverse set of career possibilities that are available to individuals with an accounting education and experience

**Course Format:**

Students will attend an orientation session. During the remainder of the semester, students will attend eight two hour sessions. At each session a speaker will talk about a designated topic for approximately 60 minutes followed by a 15 to 30 minute question and answer period. The last session of the course will be a summary session where the students will be asked to complete an exit survey.

**Performance Evaluation:**

Course grades are satisfactory or unsatisfactory. Documented attendance at six of the eight speaker events and completion of the exit survey will constitute a satisfactory grade.

**Administrative Information:**

1. The course is available on an S/U basis only and may not be repeated for additional credit. The course counts as general degree credit.
