1.3 Textbook

For this course, students need to purchase 'Financial & Managerial Accounting for MBAs', by Easton, Wild, Halsey, McAnally, Hartgraves and Morse. Cambridge Business Publishers, 3rd edition 2013, ISBN: 978-1618530080. Students may also buy the second edition of this textbook (which should be available at low cost). There is also a 4th edition, which we will not be using.

1.4 Course objective

The course objective is to introduce prospective managers to managerial accounting with primary emphasis on decision making using managerial accounting inputs.

2 Course Requirements

2.1 Performance assessment

The grade is determined as follows:

Midterm exam	45%
Final exam	55%
Total	<u>100%</u>

The exams are graded between 1 (lowest) and 10 (highest). The final grade is letter grade based on the following scale:

Grade	Score
A	9.00 - 10.00
A-	8.00 - 8.99
B+	7.00 - 7.99
B	6.00 - 6.99
B-	5.00 - 5.99
C+	4.00 - 4.99
C	3.50 - 3.99
C-	3.00 - 3.49
D	1.00 - 2.99

For example, if the grades are a 8.0 for the midterm (45%) and 6.0 for the final (55%), then the score would be: $8.0 \times 45\% + 6.0 \times 55\% = 6.9$, which corresponds to a B (it is in the 6.00 - 6.99 score range).

2.3 Exams

The exam will include one page with formulas. This page will be made available on the class website well before the exam.

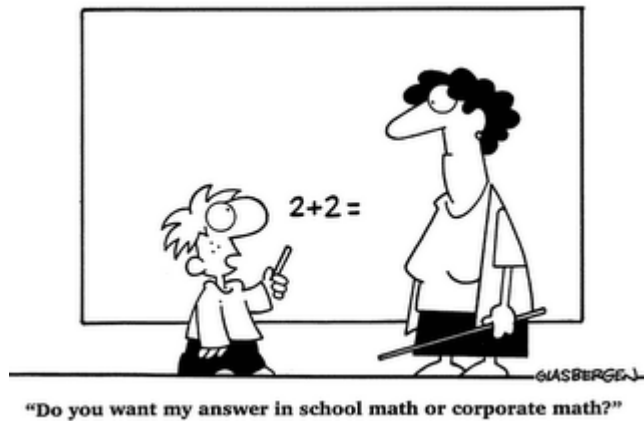
