#### ACCOUNTING COURSES

#### 102-103 PRINCIPLES OF ACCOUNTING (3, 3)

Through discussion and practice the student is familiarized with the principles and techniques of accounts of the Single Proprietorship, and the Corporation.

## 250-251 INTERMEDIATE ACCOUNTING (3, 3)

Prerequisite: Acctg. 102-103. Statements from incomplete data, manufacturing accounts, consignments, installment sales, actuarial science, inventories, depreciation methods, sources and application of funds, errors and their correction, and consolidated and comparative financial statements.

## 304 COST ACCOUNTING (3)

Prerequisite: Acctg. 102-103. The nature and purpose of cost accounting; job order costs; methods of accounting for materials, labor, and manufacturing expenses; periodic summaries and interpretation.

# 352 I-II FEDERAL TAX ACCOUNTING (3, 3)

Prerequisite: Acctg. 102-103. Federal tax accounting procedures, including legal and accounting treatment of all forms of government revenue, with practice material requiring an application of the provisions to the return of individuals, partnership, fiduciaries, and corporations.

#### 308 MONEY AND BANKING (3)

Prerequisite: Ec. 200-201. A detailed treatment of (a) the nature of money and its economic functions; (b) banking and credit and foreign exchange; (c) the commercial banking process and the evolution of the American banking system; (d) the economic effects of bank-controlled policies.

#### 316 ECONOMICS OF TRANSPORTATION (3)

Prerequisite: Ec. 200-201, or consent of the instructor. The economic significance of transportation, the responsibilities of carriers; the principles of rate-making; the regulation of modern shipping and the strategic importance and use of competing transportation media.

#### 318 ECONOMICS OF INTERNATIONAL TRADE (3)

Prerequisite: Ec. 200-201. A review of the most important theories of international trade; the principles of the international balance sheet; and a critical study of the balance of payment of the United States and foreign countries.

#### 321 REAL ESTATE (3)

The purchase and sale of real estate properties, the general economics of real estate; ownership and interests; liens; leases; mortgages; abstracts of title; the examination and transfer of title to real estate; title insurance and some aspects of real estate appraisal.

#### 420 TAXATION AND PUBLIC FINANCE (3)

Prerequisite: Acctg. 102-103, Ec. 200-201. A study of current economic doctrines, governmental expenditures, both federal and local, nature of the federal tax structure, government borrowing and indebtedness, governmental debt management, federal-state-local fiscal interrelationships, U. S. fiscal policy.

#### CHEMISTRY

Requirements for Major: Students desiring to major in chemistry are required to complete successfully (Grade of "C", or better) courses 100-101, 200, 201, 230, 231, 400-401, a year in biology, a year in physics, and mathematics through 241.

It is recommended that a student take such other mathematics as is offered. There are also elective subjects in chemistry from which he may choose to further develop his abilities in special fields of interest.

Pre-medical students should consult the professor of chemistry before registering for classes at the beginning of the freshman year.

The fundamental laws and theories of chemistry, including atomic structure; the periodic classification of the elements; states of matter,
