The minimum standards that must be met before a student will be **considered** for admission into the Fisher School are as follows:

- If the application is after the last day to drop a course the application will be held until grades are posted.
- Student **must** have at least a minimum of 60 credit hours completed, including current registration (not including AP, IB or DE credit).
- **Must** have an overall UF GPA of 3.0 or greater.
- **Must** have a minimum 3.0 preprofessional GPA
- **Must** have a grade of B or better in ACG 2021C (students are allowed a maximum of 2 attempts to earn the "B" grade).
- **Must** have completed MAC 2233 or its equivalent.
- **Must** have completed a total of all 19 preprofessional credit hours. **NOTE:** A student may receive conditional acceptance with four preprofessional courses completed at the time of application (including ACG2021C, with a grade of 'B' or better, and MAC2233).
- **Must** successfully complete any upper-division accounting courses in process.

To the best of my knowledge I meet the requirements above, and I understand that meeting the minimum standards stated above does not guarantee admission into the Fisher School. Admission is selective and is subject to enrollment capacity.
