- 3. WCB Development Update-
 - At this meeting Jon Cannon reported on the Development and Alumni Affairs team of the college, the third in a series of college area highlights previously announced by Dean Mitra.
 - Jon shared about the development team, it's organization, how they compare to other peer development teams. He noted that revenue from endowment and current use gifts makes up 16% of Warrington's annual operating budget. He shared a short Development 101. Noting engagement is very important to their team and a key area where the development office seeks to partner with everyone in the college.

We are currently in the midst of the UF Go Greater Campaign which started in fiscal year 2014-2015 and will conclude 9/2022 and is UF's 4th campaign. Our goal is \$250 million. Our endowment funds, which are defined by the donor's interests, support professorships, staff salary support, program expense budgets, facilities maintenance, technology enhancement, scholarships, and every aspect of the college.

Jon closed by sharing development goals which include closing out the current Go Greater Campaign, partnering across the college to strategically engage more alumni, attract more, better, stronger corporate partners, achieve sustainable \$15 million year fundraising, and implement high impact donors.
